NEWLY PASSED MORTGAGE FRAUD BILLS

A Mortgage Fraud Bills package was passed on 9/19/06. Issues included in these bills are 1) clarifying what makes up mortgage fraud & making it a felony, 2) allotting \$3 million from the Real Estate Enforcement Fund to the State Attorney General's Office to investigate & enforce, 3) provide prosecutors with flexibility to try cases with efficiency, 4) clarify specific actions that constitute mortgage fraud within the appraisal process and 5) protect victims by allowing the opportunity for civil retribution.
