All the monies were paid back from the Boating Account to the Checking Account. Due to the extra cost of the sidewalk and fencing the Boat account owes the Special Account money. It will take some time to pay that money back.

Boating Director Lou Tiernan gave no report. He thanked Gordon and Lee Howell for the work they did to get the new boat dock installed.

Expeditor Lee Howell gave no report. He did say that the Boat Storage Applications were available from him or Gordon if he, Lee, was unavailable. In an answer about the cost of boat storage, Lee stated that it was \$120.00 again this year. Lee thanked all the numerous helpers who helped him improve the beach this year. Paulette Howell stated that Lee and Roland Jakel sawed up the old paddleboat, which was on the grounds. **Legal Director** Don Osborne reported that there were no legal information requests, so he had no report.

Promotional Director Sharon Gwin had no report. She thanked Gordon & Lynn Woolslayer and Pam Pope.

Safety Director Bob Majka reported that there were no major problems over the season. He also said that it was a fun year. He thanked Jim Vickers for all his help. Paulette Howell asked about new buoys. Bob and Tim Daly responded that it would be a decision for the new LOHA Board.

Social Director Pam Pope thanked all the volunteers and participants for the year's activities. She reported that there were six (6) chili entries for the Chili Cook Off. The Bastiens won the contest. Pam said that the weather was great for the activities this year.

OLD BUSINESS

- Liability Insurance Lee Howell reviewed the liability insurance through Cincinnati Insurance Company through their Lapeer office. There is \$1,000,000.00 per occurrence and \$2,000,000.00 aggregate. The Association does have coverage for the boat docks under marina. Any person or member acting on behalf of the Association is covered. He contacted the Lapeer office about not needing the Products Liability and Extended Products Liability Insurance for which the Association has paid. It was agreed that those items should be dropped thus saving the Association \$310.00 a year. Lynn Woolslayer stated that a \$94.00 refund was received.
- 2. New Picnic Tables The 5 new picnic tables were delivered and the large pieces are stored in the cage. The small pieces are in the Weenie Shack. The tables came in one bundle. Lee, Bob and Gordon helped take them off the truck. They will be assembled in the spring. Paulette Howell suggested that one table be assembled to assure that all the parts were sent. Tim Daly stated that they were under warrantee. Paulette suggested that the invoice be checked for that information.
- 3. Porta Jon The porta jon was removed from the premises.
- 4. Dumpster The dumpster will be removed this week.
- 5. Sign for Barb's Garden Pam Pope stated that she removed the sign and placed it in the Weenie Shack for the winter.
- 6. Water Shut Off The water for the Weenie Shack has to be turned off and the water heater drained and removed. Lee Howell stated that he would contact someone to do those things.

Tim Daly made a motion to adjourn the meeting. Lynn Woolslayer seconded the motion. The motion unanimously passed. The meeting adjourned at 8:10 PM.
