## LOHA BOARD MEETING MINUTES OF NOVEMBER 2, 2010

Carolyn Bree brought the meeting to order at 7:32pm. Lynn Woolslayer addressed the minutes of the General Meeting on September 28, 2010. ## REPORTS

The cost is \$2,500. This included electricity to the end of the docks, and a breaker box at the docks. Tim asked where the money would come to pay John. He supposed that it would come from the Special Fund. He also asked that the circuit breakers for the pumps be labeled. Tim also reminded John to lock the gate when the last boat is out of the boat slip. He also suggested that John get the old keys for the gate before he hands out the new numbered keys. The bill for the bubblers has not been received. <u>Expeditor Bob Majka</u> had no report.

<u>Legal Director Don Osborne</u> was absent. Pam Pope reported that there were no pending legal issues at this time. She said that Don wanted to review the legal issues in the insurance policy. Lynn Woolslayer gave them to Pam to deliver to Don.

Promotional Directors, Nichole Springall and Laura Davidson, gave no report.

Safety Director Tim Daly had no report.

<u>Social Director Pam Pope</u> reported that there was a huge turnout for the costume judging, cider and doughnuts on Halloween night. She thanked those who helped at the event, especially Bob Majka for putting up the tarps.
