PROCEDURE USED FOR ASSIGNING SLIPS

When a slip becomes available in any year, the people on the list will be called in numerical order, starting with number one. If the person called accepts the slip and payment is made, then the other people on the list (after that person) will automatically move up one spot on the list, i.e., number two will move up to number one, etc. If the person called rejects the slip, but wants to remain on the list, they will maintain their same position on the list and the next person on the list will then be offered the slip, and this will continue until the slip is accepted. 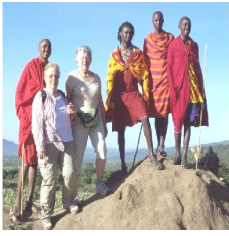
BOAT SLIP DUES
