# **OLD BUSINESS**

Lee Howell talked to Randy Dunn today for an idea on their plans. Asked him regarding their plans for beach guard and they indicated they may be available until end of school year. If we have anyone that is interested to move forward in replacing them as beach guard and Winnie Shack. Shawn Knedgen and Marilyn are interested. Lee will explore further.

Lee asked if everyone on the Board got the necessary keys to the facilities so they can perform their duties and they indicated that they did.

#### **NEW BUSINESS**

Lee reports that the new budget will be considerably less than last year's budget because the income on which the budget is based will be approximately \$8000.00 less than the prior year's income. The reason for this is two-fold. One is that no interest was taken from the investment account and deposited into the checking account during the last fiscal year, which normally would be in the area of \$1750.00-\$2000.00. The reason for this was because we had problems with the insurance company and a subsequent delay in withdrawal because of Gordon's death. The other reason is that we are not including the boat slip income of \$6200.00 into the general budget this year, since, under the current system, all boat slip income remains in the boat fund and is not available for general use. In the past, we have mistakenly included this income into the general budget, which created an overstated budget (amount available for general use). Thus we are going to have a budget shortfall this year and we will discuss how to correct this shortfall at the December general meeting

Don Swanson proposes a new project of labeling the electrical panel in the pavilion.

Proposed budget was reviewed by the Board as amended.

Lynn motioned to accept budget as amended, Don Swanson seconded and all approved.
