OLD BUSINESS

Lee Howell stated he received a call from Brian at Michigan Marine to check the status of our seawall permit. Lee checked with the field agent, Patty, she said it was in process. Lee will

check on the status again this week since it was submitted first of April. Brian from Michigan Marine hopes to start project by the end of September.

Lee stated that we have various items to discuss at the Special Meeting,

- 1. We need to make a by-laws change in Article XI, Section 4, Investment Account, sub-section a. We should eliminate the last sentence, of The minimum principal amount to remain in this account at all times is Seventy Thousand Dollars (\$70,000.00), os since we will e using approximately \$56,000.00 of this money to pay for the seawall, which would leave about \$18,000.00 in the investment account. However, we dong know exactly how much we will be using for the seawall and we did authorize a total of \$65,000.00, if necessary. All of the money in the investment account has been taken out of the American national Annuity and is currently in the Savings Account. Whatever amount is left of the investment money after we pay for the seawall we will re-invest, probably in a separate interest bearing account. We should make the by-laws change before we actually spend the money for the seawall so that we will be in compliance with the by-laws when we do use the money.
- 2. The next topic for the Special Meeting is to approve money to be withdrawn from the Savings to cover the budget shortfall and specifically to be used for payment for the beach guard for the current fiscal year. We should approve a total amount of no more than \$4500.00 since that is the usual amount budgeted for beach guard. We will then use the money as needed during this fiscal year, up to but not exceeding the approved amount.
- 3. To seek approval to raising general membership dues for the next fiscal year of 5% (maximum amount allowed in by-laws) which is \$3.00 for each membership for both regular and senior and 6% for boat slips (maximum amount allowed in by-laws), which is \$12.00 per slip.
- 4. The final topic for the Special Meeting will be; to seek approval to allow the dredged material from the canal to be put on LOHA beach property to drain before it is hauled away. Paul Hausler, Consulting engineer for the Lakes Board has assured Lee of the Following; dredge canal, run it through a pipe, down to our beach property where it will be encased in a large plastic porous bag 10øwide x 30ølong to drain the water for a period of a week or two and then it will be hauled away

Lee made a motion to allow the MDEQ access to our property next to Taylorøs property, put a 10X30 bag to drain for a period of 2 ó 4 weeks approximately in 10/2016.

Jim William seconded the motion. Motion was unanimously carried.

NEW BUSINESS

A Special Meeting will be held prior to the July 19, meeting at 7:00 pm to discuss the four items above.

All agreed.

Pam Pope mentioned that unaccompanied kids were at the beach area, when approached and after having a discussion with them; Pam indicates to the Board that the Beach rules and the posted sign do not agree. Should state, under the age of 12 must be accompanied by an individual 16 and over.

Pam Pope recommended that any call regarding rental issues should be referred to Shawn.
