OLD BUSINESS

Lee Howell shared the revised Boat Club rules and regulations for 2017,

After discussion and comments, Lee made a motion to accept the Boat Club rules and regulations as written, Don Osborne seconded the motion and the motion was unanimously approved.

Due to the low checking account balance and after all the improvements to the LOHA property \$1000.00 was transferred from savings to checking until income is received for boat storage. Also, a transfer of 20% from general checking and from the boat fund has been transferred to the savings account, per By-Laws.

Lee Howell states that since the LOHA membership dues were reduced in 2008 to the point that income has not been meeting our expenses and only the maximum allowed increase for fiscal

year 2016-2017 was approved; the Board is recommending another increase for fiscal year 2017-2018 because income is not meeting the ever increasing expenses to maintain the LOHA property.

Joe Swain asked if the boat storage fee would be increased, Lee replied, "not at this time."

Lee Howell made a motion the increase dues for Fiscal year 2017-2018 by the 5% maximum for the LOHA Membership and 6% for the Boat Club. Regular Membership dues would increase from \$72.00 to \$76.00 and Senior Membership dues would increase from \$58.00 to \$61.00. After discussion and comments, Mary Lou Osborne made a motion to accept, seconded by Jerry Chamberlain and the motion was unanimously approved.

NEW BUSINESS

Charlene Valante who has been taking care of the plants and flowers around the entrance signs is in need of help or for someone to take over this project completely.

Courtney Green volunteered to work on this project.

Mary Lou Osborne shared that she is coordinating a work-bee project for October 7, to repair and paint the LOHA entrance signs and needs four to five volunteers for each sign. Volunteers should meet at the Embarcadero Street sign, bring scraping tools. Paint, brushes and other tools will be made available.

Don Swanson asked when we would discontinue opening the main gate. Lee Howell stated that as of today the main gate will remain closed; however it can be opened by request for boat removal/storage. Don Swanson would appreciate that if you open the gate by request that you also take responsibility to close it.

Don Swanson asked for input on a solution/method to repair the stationary receiving steel post of the main gate.

Lee Howell will check with Jim Vickers to have his son in law drain and shut down the hot water tank. Or the pipe can be cut; drain the tank, then in the spring Jerry Chamberlain will reinstall it with a union pipe connection
