LOHA BOAT CLUB RULES AND REGULATIONS

Revised 2017

- 1. All boat slip renters must be a paid up member of Lake Oakland Heights Park Association and a resident of Lake Oakland Heights Subdivision at all times during slip rental.
- 2. You must pay the current boat slip rental fee at the time or prior to the time the boat is put into your slip each year. If you have not paid the boat slip rental fee and completed, signed and submitted the rnter's agreement, you should not have your boat in the slip. **No exceptions.**
- 3. Boat slip renters must also provide to L.O.H.P.A. proof of ownership, that you, the renter, are the current registered owner of the boat in the slip and provide a current copy of the proof of insurance for that watercraft. This also must be provided at the time or before the time the boat is put into the slip. If you have not submitted this information, you should not have your boat in the slip. **No exceptions.**
- 4. No slip renters shall be allowed to sub-lease their slip to anyone at any time or allow their slip to be used by anyone other than themselves of members of their immediate family residing in their household.
- 5. If you gas your boat while it is in the slip or on the boat ramp, take precautions to not spill gas into the lake water.
- 6. No boat will be left at the courtesy dock or next to the vacant lot overnight.
- 7. There will be no guest rental of any slip.
- 8. Each boat slip renter is entitled to one gate key only and one key to the boat launch. Do not allow anyone other than yourself or members of your immediate family to use these keys on a regular basis.
- 9. Boat owners must lock their boat when not in use. Also, boat slip renters are responsible for locking the boat dock gate and boat ramp lock after use.
- 10. L.O.H.P.A. shall not be held responsible for any damages to any boat while in the boat slip or at any other location. All boats are the owner's responsibility.
- 11. All State and County safety regulations shall be complied with and it is the boat owner's responsibility to do so.
- 12. There shall be no parking of watercraft trailers in the beach parking lot on Saturdays, Sundays, Holidays or during L.O.H.P.A. scheduled events.
- 13. There shall be no smoking of tobacco products by anyone while they are on the boat docks or inside of boats while they are docked.
- 14. Any infractions of any of the above Rules and Regulations will result in a verbal or written notification from L.O.H.P.A. and an automatic review by the L.O.H.P.A. Board. L.O.H.P.A. reserves the right to revoke any boat slip renter's agreement and/or removal of the renter's boat at any time during the fiscal year.
- 15. All boat slip renters will be provided a copy of these Rules and Regulations at the time their slip rental agreement is completed and signed.
- 16. Rental of a boat slip is a privilege, not to be abused. We have a long list of people waiting for a slip who will be glad to comply with the rules, so please make every effort to comply.
