ID tags will be issued and required to be shown when on the beach property, including the playground. The ID tags will be distributed on Sundays after a member pays dues and the checks clear the bank. Deposits will be made on Saturday mornings. Cards will be distributed one week after that. Ex: Checks deposited on Sat., May 4, members will receive their cards on May 12. If deposited on May 11, members can pick up their cards at the Beach Opening or will be delivered May 18. Cards are required for participation in the day's events. Only checks received by Fridays will be deposited on Saturday. Dues pay for property maintenance and improvements.
